

## GENERAL RULES AND REGULATIONS

### ART. 1

The Competition is open to opera singers of all nationalities, without age limitation.

### ART. 2

The Application form must be sent no later than **14th August 2018** to the following address *concorsolirico2018gmail.com*.

The Application form must necessarily enclose the following documents:

- Professional Curriculum Vitae
- Copy of a valid identification document (ID or Passport)
- A recent photo (one or more)
- Copy of the registration fee of € 70.00 (seventy/00) made with bank transfer on the following account: ASSOCIAZIONE NOVA HARMONIA  
IBAN: IT47K0310450910000000820701 - Swift/bic DEUTITMM
- Candidate's consent to the handling of personal data as regulated by Italian Legislative Decree n.196/2003 - The Competition's fee is non-refundable

### ART. 3

All candidates must present max 4 opera arias from the international repertoire. The program must necessarily include at least 2 arias in Italian.

### ART. 4

The Competition organizers will provide accompanying pianists for the performances of the competitors. Competitors are free to have their personal accompanist at their own expense.

## COMPETITION

### ART. 5

The Competition will take place in Bellano at Cinema Teatro, Via Roma 3 from 16th to 18th August 2018 with the following schedule:

- 16 th August: Eliminations from 10.30 to 20
- 17th August: Semi-finals from 11 to 14 - Final from 17

Competitors who won or reached the finals in 2016/2017 others international opera singing competitions, will be directly admitted to the semi-finals (upon presentation of documentation attached to the Application Form).

The Competition's winners must take part at the concert on 18th August organized by Comune di Bellano. They will be accompanied by LAKE COMO PHILARMONIC ORCHESTRA conducted by Maestro Roberto Gianola.

Winners that will not exhibit on the final concert will be out of the qualification and out of prize.

## PRIZES

### ART. 6

First prize: a scholarship of 1.500 € - Concert by Opera Teathre of Istanbul

Second prize: a scholarship of 900 € - Concert by Lake Como Philharmonic Orchestra

Third prize: a scholarship of 600 €

Special awards:

MIGLIOR GIOVANE - max 25 anni (Best young performer max 25 years)

PREMIO INTERPRETAZIONE (Best performance)

Others awards: Deserving singers may be contacted for seasons at Theatre of Oviedo, Las Palmas, Istanbul; for Festival "Bellano Lirica". All finals Competitors will receive a Certificate of Merit.

The panel of judges can interrupt the performances at its discretion.

Associazione Nova Harmonia reserves the right to photograph and film/record all the rounds of the Competition.
